Pursuant to the Revised Missouri Statute 479.050 rule 37.49 of the Supreme Court Rules of the State of Missouri, and Local Court Rule 69.6 designated offenses shall be payable to the City of Breckenridge Hills Violations Bureau.

The Violations Bureau established convenience to the public. It is not intended to replace a court appearance of plea of "Not Guilty." If you believe you are not guilty of the offense charged, you should appear in court on the court date indicated on your summons.

In all cases before the Traffic Violations Bureau and the Municipal Court where the defendant pleads guilty or is convicted, there shall be collected for such defendant, in addition to the fine or other punishment imposed, the sum of twelve (\$12.00) as court costs. In addition to such court costs, a fee of two dollars (2.00) shall be assessed and collected and set aside in a separate fund by the City Treasurer to be used solely for training of Police Officers. A fee of one dollar (\$1.00) shall be assessed and collected and set aside to be used by Statewide for Training Law Enforcement Officers to be deposited into the Peace Officers Standards and Training Commission Fund. A fee of seven dollars fifty cents (\$7.50) shall be assessed and ninety-five (95%) of this fee shall be deposited in the Crime Victims Compensation Fund and five percent (5%) of this fee shall be deposited into the General Fund. A fee not to exceed (\$2.00) shall be assessed for the Weinman Shelter and shall be deposited in the Domestic Violence Shelter Fund. A fee of two dollars (\$2.00) shall be assessed, collected and set aside in a separate fund called Inmate Security Fund, to be used for costs associated with biometric verification systems, and for any expenses related to custody and housing and other expenses for prisoners. A fee of seven dollars (\$7.00) shall be assessed, collected and set aside for the Statewide Court Automation Fund, with all such amounts collected, transmitted monthly to the Missouri Department of Revenue to the credit of the Missouri Statewide Court Automation Fund.

Copy of judicial records (for filing notice of appeal, accepting bond or recognizance thereon, preparing transcript on appeal.)

The following fines and costs have been established for the City of Breckenridge Hills for offenses issued on or after October 31, 2026, and until further notice. However, court fines are subject to change (with an appearance in court) at the Judge's discretion.

Violations not appearing on the list are NOT payable out of court and require a court appearance.
